# Independent Limited Assurance Report

## to the Management of thyssenkrupp Plastics GmbH

thyssenkrupp Plastics GmbH (thyssenkrupp Plastics") commissioned DNV Business Assurance Germany GmbH ("DNV", "us" or "we") to provide limited assurance over Selected Information used by thyssenkrupp Plastics and associated companies within the Plastics Operating Unit (together referred to here as "thyssenkrupp Plastics companies") as the basis for issuing product carbon intensity certificates.



**Our Conclusion:** Based on the procedures we have performed and the evidence we have obtained, nothing has come to our attention that causes us to believe that the Selected Information is not fairly stated and has not been prepared, in all material respects, in accordance with the Criteria. In our opinion the methodology for calculating product CO<sub>2</sub>eq intensities has been prepared in general alignment with the WRI/WBCSD GHG Protocol Product Lifecycle Accounting and Reporting. Customers of thyssenkrupp Plastics that receive these certificates can utilise these product CO<sub>2</sub>eq intensities in their Scope 3 emissions reporting in accordance with the GHG Protocol Corporate Accounting and Reporting Standard. This conclusion relates only to the Selected Information and is to be read in the context of this Assurance Report, particularly the inherent limitations explained overleaf.

#### **Selected Information**

The scope and boundary of our work is restricted to the data and methodology described below (the "Selected Information"):

- Product CO<sub>2</sub>eq intensities: The amount of CO<sub>2</sub>eq per tonne of product covered by the methodology relating to products handled by thyssenkrupp Plastics companies (as listed below) (the "Entity");
- The methodology: the detailed description developed by thyssenkrupp Plastics companies of the processes and data sources used to calculate product carbon intensities;
- Product carbon footprint tool: the spreadsheet containing current year data from thyssenkrupp Plastics companies (as listed below) and calculations to determine product carbon footprints in accordance with the methodology.
- The thyssenkrupp Plastics companies covered by the product carbon footprint tool are listed in the Appendix below.

#### Criteria

We assessed the methodology and data of thyssenkrupp Plastics for calculating product  $CO_2eq$  intensities against the following **Criteria** (the "Criteria"):

- The publicly available Greenhouse Gas Protocol Product Life Cycle Accounting and Reporting Standard, as issued by WRI/WBCSD;
- The internal procedure for issuing certificates and tracking customer transactions; and
- The methodology document [summary available on request from thyssenkrupp Plastics] on the product CO<sub>2</sub>eq intensities, including their following definitions and programme rules:
  - Product CO<sub>2</sub>eq intensities: The amount in metric tonnes of CO<sub>2</sub>eq associated with each tonne of product. The CO<sub>2</sub>eq intensities calculation is conducted in alignment with the Greenhouse Gas Protocol Product Life Cycle Accounting and Reporting Standard.
  - Reporting period: The CO<sub>2</sub>eq intensities have been calculated based on data from the time period October 2022 to September 2023.
- DNV will conduct periodic reviews of the certificates issued and use of the product carbon footprint tool after twelve months.

#### Standard and level of assurance

We performed a **limited** assurance engagement in accordance with the International Standard on Assurance Engagements (ISAE) 3000 revised – 'Assurance Engagements other than Audits and Reviews of Historical Financial Information' (revised), issued by the International Auditing and Assurance Standards Board. This standard requires that we comply with ethical requirements and plan and perform the assurance engagement to obtain limited assurance.

DNV applies its own management standards and compliance policies for quality control, which are based on the principles enclosed within ISO IEC 17029:2019 – Conformity Assessment – General principles and requirements for validation and verification bodies, and accordingly maintains a comprehensive system of quality control including documented policies and procedures regarding compliance with ethical requirements, professional standards and applicable legal and regulatory requirements.

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement; and the level of assurance obtained is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed. We planned and performed our work to obtain the evidence we considered sufficient to provide a basis for our opinion, so that the risk of this conclusion being in error is reduced but not reduced to very low.

#### **Basis of our conclusion**

We are required to plan and perform our work in order to consider the risk of material misstatement of the Selected Information; our work included, but was not restricted to:

- Assessing the appropriateness of the Criteria for the Selected Information;
- Conducting interviews with the technical teams and other key personnel of thyssenkrupp Plastics to obtain an understanding of the key processes, systems and controls in place to generate, aggregate and report the Selected Information;
- (Remote) audits at the sites Roskilde (DNK), Roosendaal (NL) and Tornesch (DE) to review evidence to support specific site-level data. We were free to request interviews, data and information to support the process;
- Performing limited substantive testing on a selective basis of the Selected Information to check that data had been appropriately measured, recorded, collated and reported; and
- Reviewing that the evidence, measurements and their scope provided to us by thyssenkrupp Plastics for the Selected Information is prepared in line with the Criteria.

The Management of thyssenkrupp Plastics have sole responsibility for:

- Preparing and presenting the Selected information in accordance with the Criteria;
- Designing, implementing and maintaining effective internal controls over the information and data, resulting in the preparation of the Selected Information that is free from material misstatements;
- Measuring and reporting the Selected Information based on their established Criteria; and
- Contents and statements contained within product carbon intensity certificates

Our responsibility is to plan and perform our work to obtain limited assurance about whether the Selected Information has been prepared in accordance with the Criteria and to report to thyssenkrupp Plastics in the form of an independent limited assurance conclusion, based on the work performed and the evidence obtained. We have not been responsible for the preparation of the certificates. We have not reviewed whether or how thyssenkrupp Plastics customers have used the reported CO<sub>2</sub>eq intensities in their Scope 3 reporting.
